RULES

Art. 1 – Participation to Expo Challenge Venice

It is allowed to attend Challenge Venice's sponsors, Bodies and Public Institutions, Tourism Promotion Agencies, Tour Operators, Associations, Consortia and sport tourism Cooperatives, Farm, Tour operators, Travel agencies, Specialized Publishing, sportswear Case, organizers of shows and sporting events, manufacturers and distributors of sporting goods and related sectors. Note: Any activity, including promotional, conducted within the exhibition space it must be agreed with the direction of Expo.

Art. 2 – Prohibition details

It is expressly forbidden:

- To stay in the area of the event in the closing hours of the expo
- To circulate with vehicles of any kind within the area of the Expo
- to use the brand Challenge Venice if not authorized

Art. 3 – Sale to public

It is possible to sale to public, but you have your own sales license

Art. 4 – Costs and payment

Costs are indicated in the participation form. The form is to be accompanied by the advanced payment of the 50% of the total amount. The balance must be paid before the opening of Expo after excluding from Expo Challenge Venice same. At the end of the event will be sent the invoice.

Art. 5 – Withdrawal by the exhibitor

The signing of the Participation Form constitutes the agreement between Organizer and Exhibitor. The withdrawal of the agreement is possible if the request is received by the Organization at least thirty days before the event, accompanied by the payment as a penalty and lump sum compensation damages, the total amount equal to 50% of the rent due.

Art. 6 – Set up

The Expo is set up in Mestre – at the entrance of Parco San Giuliano, from PORTA ROSSA parking. The space and the booths are provided by the Organizer. The set up of the booth is allowed from 8.00 am to 1 pm of Friday June 9

Art. 7 - Dismantling

Dismantling is possible from 11 pm of Sunday June 11 till Monday 12 all day
